

# Changyou.com Begins Open Beta Testing of *"Legend of Ancient World"* on May 19, 2011

**Beijing, China, May 19, 2011** – Changyou.com Limited ("Changyou" or the "Company") (NASDAQ: CYOU), a leading online game developer and operator in China, today announced that it began open-beta testing of *Legend of Ancient World*, the Company's first 2.5D oriental fantasy massively multi-player online role-playing game ("MMORPG") today.

*Legend of Ancient World* was licensed from a game studio in China. Transporting players back some 4,000 years to the ancient Huaxia period, the game allows players to explore an ancient Chinese civilization while experiencing 21 occupations, 9 challenging dungeons and over 50 different mounts for players to ride. The downloadable client software is only 0.4GB in size which will make it fast and easy to download to computers.

Mr. Dewen Chen, Changyou's president and chief operating officer, commented, "As our first time travel MMO game, Legend of Ancient World should appeal to players who like civilization games and imaginative storylines. Its launch adds another high quality licensed game to our portfolio and should help bring more gamers to our platform."
